NFHS Wrestling Weekly Rule Interpretations


This week's interpretation discusses a very important topic that deals with Head, Neck and Cervical Column and/or Nervous System (HNC) injury protocol. As mentioned before, we will discuss illegal moves (in depth) later this season. HNC is critical because of the body parts that are involved, and the continuance of a wrestler is determined based on the severity of their injury. These illustrations provide guidance in both situations. It is important that as referees, we understand that we have an obligation to observe if a wrestler is exhibiting signs, symptoms or behaviors consistent with a concussion or injury to the head, neck, cervical column and/or nervous system. The feedback that we are receiving remains positive and encouraging. Thank you for your ongoing support this season.

We hope that the illustrations are helpful and timely for your wrestling referees to discuss and use as talking points during their officials' chapter/board meetings this season and post-season. We are attaching the illustrations as separate documents for your use and for ease of distribution. These resources are excellent conversation starters for first year and seasoned referees alike! Have a wonderful start of the wrestling season.




Head Neck and Cervical (HNC) Protocols

Wrestler A shoots

Frame 3:

Official directs coach to attend to Wrestler A. After 1:10 Wrestler A is ready to continue to wrestle.


Injury time must be recorded on the bout sheet. (ex. Injury time 1:10) **Rule 6-4-3:** ... If a wrestler is injured due to a legal or illegal action, the referee shall stop the match under these certain conditions: a)injury time; b) blood time; c)recovery time; d) referee's time; e) Head/Neck/Cervical Column (HNC) injury time

Rule 8-2-4a: ... Any contestant who exhibits signs, symptoms or behaviors consistent with a concussion (such as loss of consciousness, headache, diizziness, confusion or balance problem) shall be immediately removed from the match amd shall not return to competition until cleared by an appropriate health-care professional.

Rule 8-2-4b.1: ... In the absence of appropriate health-care professional, (physician and/or certified athletic trainer) all injuries to the head and neck involving the cervical column and/or nervous system will be covered by 8-2-4a.

Rule 8-2-6: ... During a timeout for injury, blood time, recovery time or head and neck involving the cervical column and /or nervous system time, two team attendants and appropriate health-care professional shall be permitted on the mat with either wrestler. Coaching shall be allowed during injury time, blood time, recovery time, and HNC time-out.










Head Neck and Cervical (HNC) Protocols Illustration A-2 WITH Appropriate Health Care Professional On-Site



Frame 1:

Wrestlers shoot and bang heads causing Wrestler A to grab his neck and drop to a knee.

Frame 2:



Frame 3:



AHCP arrives and requests extended time to evaluate Wrestler A. Official signals HNC time.

Frame 3a:



Wrestler A sustains

Injury time transitions to HNC time. The **AHCP** clears **Wrestler A** to continue wrestling before the 5 minute time expires.

Frame 4:



Frame 5:
Each wrestler may use just one HNC time-out per match.
Wrestler B wins by default.

Rule 5-28-6: ... Head/Neck/Cervical Column (HNC). If a contestant is injured, the onsite AHCP will have up to five (5) minutes (maximum) to evaluate the wrestler's head and neck involving the cervical column and/or nervous system. A second occurrence to the head and neck involving the cervical column and/or nervous system in the same match shall require the wrestler to default the match.

Rule 6-4-3: ... If a wrestler is injured due to a legal or illegal action, the referee shall stop the match under these certain conditions: a)injury time; b) blood time; c) recovery time; d) referee's time; e) Head/Neck/Cervical Column (HNC) injury time.

Rule 8-2-4b.2: ... When appropriate health-care professional(s) (physician or certified athletic trainer) are present they have jurisdiction to evaluate the injured wrestler for injuries to the head and neck involving the cervical column and/or nervous system only during the allowed time limit (maximum of five (5) minutes. After that evaluation, the wrestler would be required to prepare without delay for continuation or default the match.

Rule 8-2-4b.3: ... A second occurrence of injury to the head and neck involving the cervical column and/or nervous system in the same match shall require the wrestler to default the match.

Rule 8-2-5: ... A designated, on-site meet, appropriate health care professional who determines a wrestler should not participate, shall not be overruled.
